The Search for the Green River Killer John Wayne Gacy Few serial killers in history have garnered as much attention as Jeffrey Lionel Dahmer. Although Dahmer killed seventeen young men and boys, it was not so much the number of people he killed that

makes him stand out among famous serial killers, but more so the acts of depravity that he committed on the corpses of his victims. In this true crime story vou will read how Dahmer transitioned from a loner to serial killer, committing numerous unnatural acts along the way such as necrophilia and cannibalism. Following in the macabre tradition of another infamous Wisconsin

serial killer-Ed Gein-Jeffrey Dahmer terrorized Milwaukee for most of the 1980s until he was finally captured in 1991. Perhaps one of the most frightening aspects of Jeffrey Dahmer's serial killer career was how easy he was able to lure his victims into his trap.
