Civil Documents for Immigrant Visa - Consular Processing  
 Each individual immigrating to the United States must submit to the NVC copies of civil documents issued by an

appropriate authority and then present the originals at the time of the immigrant visa interview. The original Form I-864 and supporting documents will be submitted to the NVC.
