Arguing against restricting the meaning of purity language to the individual moral sphere (as many commentaries do), the central argument of *Purity and Worldview* in the Epistle of James is that purity language both articulates and constructs the worldview in James's epistle. For first-century people, cosmology was a fundamental part of their worldview.
