3. Products/Services - A description of how you will turn a profit (aka, what are you selling?). Pictures, diagrams, and prototypes are often required. Suppliers, costs, and net revenue expected for each product are discussed here.
4. Market Analysis/Economics - Outline your market research here and present your conclusions about your market analysis. Include market size, trends, patterns, and potential growth here...Exam: 83.
